## Look Before You Leap ... The Dangers of Race To The Top

The rush to qualify for federal Race To The Top (RTTT) grants would require overhauling California's content standards and creating a new state testing system, and mandate teacher compensation and evaluation be based "significantly" on student test scores. CTA leaders have met with Secretary Arne Duncan. Members have testified at several legislative hearing, and CTA and NEA have submitted formal responses to the proposed guidelines. All of our actions have had some impact, as the U.S. Department of Education was overwhelmed by the number of responses and has delayed adopting regulations top allow more time for review.
